We are now accepting a limited number of advertisements for the Del Norte/Eastgate newsletter. Ad space is available on a first-come, first-serve basis to local companies that provide products and services to our homeowners; coupons or coupon codes are encouraged.

Company advertisements will be included on the HOA community website (DNEGcommunity.com), on our Facebook page, in welcome baskets given to new community residents, as well as a sign on our ad wall at our community pool. (The company must supply the Cora-plex 24"x18" print board which the HOA will properly post and maintain for the duration of the upcoming pool season.) A PDF version of the newsletter will be posted on our website after being distributed to our residents. Advertisers may request that a paper copy be sent to the business address.

The rate for a 3.5" x 2" ad in the newsletter is \$400 for 4 publications. It is the responsibility of each business to create and submit the ad to us, as we are not graphic designers. We will allow some flexibility on the size for formatting reasons; however any ads exceeding 3.5" x 2" will only be accepted if there is enough space available on the ad page to accommodate it. As there is no price difference between ad sizes, we reserve the right to adjust ad image size. We may increase your ad size as needed to fill space, as long as the image quality remains acceptable, or we may decrease your ad size down to the 3.5" x 2" standard size, but no smaller.
